

MOTIONS

- 1. That the 2023 State Convention of the Liberal Party of Australia, NSW Division RESOLVE, by ordinary motion, to:
 - 1. Reject outright the trade principle of protectionism.
 - 2. Oppose calls from within the Liberal Party to abandon free market economics in favour of heavily subsidising and protecting domestic manufacturing.
 - 3. Recognise the need to diversify Australia's trade partner base, particularly toward like-minded liberal democracies.

Moved: Young Liberal Council

- **2.** That the 2023 State Convention of the Liberal Party of Australia, NSW Division RESOLVE, by ordinary motion, to:
 - 1. Recognise that members of the Liberal Party elected to parliament need to better reflect the diverse make-up of modern Australian society in order to increase electoral appeal;
 - Call on the Liberal Party to implement a UK Conservative Party-style 'Selection List' to increase opportunities for women and culturally diverse candidates to enter politics: and
 - 3. Reject the introduction of hard gender and identity quotas as these measures are contrary to the Liberal value of merit.

Explanatory Note:

Under Australia's Federation the vast majority of government services are supplied by State Governments. However, the 80 per cent of tax revenue is collected by the Federal Government.

NSW Liberal Party

This fact has created a number of distortions in our public debate, politics, elections and inefficiencies.

In terms of elections at a state level political parties are encouraged to promise more money for services and groups full well knowing that the bill will mostly be paid for by the Federal Government. At Federal elections, there is an incentive to advocate for lower taxes and greater spending on social welfare transfer programs knowing that cuts will need to be explained by the service deliverer at a state level.

This funding and taxation system creates inefficient duplication. Canberra has a department of education that runs not a single school, a department of health that does not run a single hospital, a department of infrastructure that does not build any infrastructure and the list goes on. All of these departments cost billions of dollars to run.

As the Liberal Party we believe in subsidiarity, that is services are best delivered by the government level closest to the people using it. The problem with federal funding is that it inevitably leads to central control of the service, for example the national curriculum that has the absurd result of trying to teach people in Broome exactly the same way you would teach someone in the southern suburbs of Hobart.

Competitive federation is another liberal ideal that when applied allows for division of power, greater control by the end user, experimentation and choice when systems fail. When there is central control the system fails everywhere, there is no choice or escape and there is little to no experimentation. We have seen this played out in the education space.

Propose that the employee share scheme should be treated under the capital gains tax.

Explanatory Note:

The Liberal Party believes in work and prosperity for ALL Australians, this requires policy that helps drive the economy, incentivise workforce participation and provide households with choices for them to be able to make the best decisions for their circumstances rather than be dictated to by government.

The Human rights commission states that the current gender pay gap is 17.2% whilst superannuation which is directly linked to paid work shows that the current average superannuation payout for a women is a third of the payout for men - \$37,000 compared with \$110,000. Action by government is required to close these gaps.

The Federal Liberal Parliamentary Party should consider a suite of policy to improve equity and choice for households in relation to workforce participation, pay and superannuation. The policies should take into consideration how households can have greater choice regarding how and when they participate in paid and voluntary work, caring responsibilities, and further study. To minimize cases where one partner in the household is faced with limits in carer progression, salary growth and superannuation contributions due to caring obligations the Liberal party should consider policies which incentivises households to participate to their full potential in the workforce, allow for equality from investments such as superannuation.

The current Childcare Subsidy System (CSS) does not provide fair access for families who cannot easily access childcare due to remote rural and regional locations and those who work nonstandard weekday 9am – 5pm hours. This includes but is not limited to Tradespeople, Real Estate agents, Pharmacists, Doctors, Nurses, Retail, Tourism and Hospitality sector workers and other shift workers.

Introducing the option for families to use a tax-deductible, flexible, in-home care options will drive workforce participation. Estimates provided in the (Un) Taxing Child-care report indicate the policy could generate a \$3.9 billion economic output (roughly the equivalent of the Australian Diary Industry).

Current Australian taxation rules only allow for a partner to claim a tax offset of up to\$540 to per year on behalf of your spouse (Married or defacto) if their income is below \$40,000. Changes to increase this allowable tax offset amount and threshold would improve the superannuation gender gap.

By supporting policy that reduces the gender pay and superannuation gap the Liberal Party will have a platform by which they can appeal to female voters which were lost to the party at previous elections.

That the 2023 State Convention of the Liberal Party of Australia, NSW Division RESOLVE, by ordinary motion, to:

- 1. Request for a Formal Inquiry to recognise the gravity of the issues within the strata scheme system and the profound impact on the lives of NSW citizens;
- 2. Call upon the Government of the day to support the initiation of a formal inquiry into the strata system in NSW;
- 3. Propose an inquiry into bullying within strata and the overall conduct of strata schemes:
- 4. Advocate for the inclusion of a clear and strict code of conduct in the Strata Scheme Management Act to combat bullying and abuse within strata schemes, with strong enforcement mechanisms;
- 5. Propose the establishment of a dedicated body with qualified legal representatives to address strata disputes and enforce orders promptly;
- 6. Propose that non-compliance with orders should result in automatic enforcement without further NCAT hearings, and penalties for those who ignore orders;
- 7. Advocate for the reinstatement of council oversight for strata defects, rectifications, and renovations;
- 8. Provision for forensic accounting to be undertaken by Order when there is any indication of misappropriation or mismanagement of funds;
- 9. Recommend that expenditures exceeding \$10,000 require voting by 80% owner-voting threshold;
- 10. Propose that any payments for invoices related to non-urgent works, which have not been approved by the owners, should be deemed an automatic breach, subject to fines;
- 11. Suggest that legal dispute costs be capped in relation to NCAT hearings for the above:
- 12. Propose implementing compulsory education and evaluations, as well as establishing clear codes of conduct for committee members, similar to the Duties of Directors outlined in the Corporations Act 2001 (Cth);
- 13. Advocate for limits on the tenure of strata committee members:
- 14. Call for a fair and balanced approach in holding committee members accountable, similar to the punitive measures applied to owners in NCAT;
- 15. Advocate for more detailed agendas and minutes of strata meetings to ensure transparency:
- 16. Suggest recording all strata meetings and providing them via a website with owner access;
- 17. Call for the mandatory provision of information regarding strata minutes, meetings, agendas, correspondence, fines, and tribunal orders to all owners, including investors or absent owners;

- 18. Propose a complete digital transparency policy to encourage honest reporting and conduct;
- 19. Advocate for anonymous strata voting and suggest implementing an 80% owner-voting threshold to prevent intimidation and discrimination based on fear
- 20. Recommend that strata managers be more independent of committees and accountable to all owners:
- 21. Call for strata managers to be legally-bound to perform in a non-discriminatory manner:
- 22. Propose that Fair Trading take stronger action, including license removal, against strata managers found in breach more than twice;
- Note that sales of all strata lots must come with a Common property defects certificate and report, a certificate from the Strata manager and committee declaring there to be no outstanding issues, bylaws, conflicts that will be inherited by a new purchaser. It is impossible for buyer beware in strata as the owner purchaser would need to be either an archaeologist or investigative detective to find these issues in Strata searches if they are hidden and not included in the minutes. Taking the Strata manager to the tribunal over flawed or inadequate Strata searches can sometimes be more costly than the issues themselves. How does one know if items are not included when one does not know of the existence of these items. The new purchaser does not want to take their building management on in a legal dispute the minute they move in. They should not have to pay for legal action regarding issues that were not transparent on purchase or not resolved decades ago. When a person purchases a property, they are already financially stretched by the purchase how are they then supposed to ramp up legal action against the building where they wanted to live in peace and start a new life;
- 24. Advocate for the inclusion of a Common Property Defects Certificate and report with all strata lot sales:
- 25. Propose a certificate from the Strata manager and committee declaring no outstanding issues, bylaws, or conflicts;
- 26. Call for comprehensive transparency in Strata searches for prospective buyers; and
- 27. Propose requesting a thorough review of the conduct and actions of strata stakeholders to ensure they align with the best interests of strata owners.

Explanatory Note:

In New South Wales (NSW), approximately 1.2 million people currently live within 84,000 strata schemes. Projections indicate that by 2040, half of Greater Sydney's population will reside in strata schemes. Despite this substantial and growing demographic, there exists

a pressing issue: the lack of adequate protections for individual owners facing potential abuse of power by Strata Committees and the lack of accountability applied to breaches and misconduct.

Issues at Hand:

- 1. Abuse of Power: The latitude given to committee members under qualified privilege, along with the limited application of damages, provides a green light for continued abuse of power within strata schemes.
- Lack of Accountability: The system of self-regulation within strata communities often leads to issues of racism, discrimination, favouritism, ignorance, double standards, and bullying. There is no guarantee that committees, building managers, and strata managers always act in good faith.
- 3. Ineffective Dispute Resolution: The responsibility for enforcing the Strata Schemes Management Act (SSMA) currently falls on individual owners, who often must spend substantial amounts of their own funds. In many cases, owners are reaching into their superannuation and pension to fund their disputes. The NSW Civil and Administrative Tribunal (NCAT) is inconsistent in its application of the law, and disputes can become endless cycles.
- 4. Mental Health Impact: The ongoing disputes and lack of effective resolution mechanisms have taken a toll on the mental health and wellbeing of strata owners.
- **43.** That the 2023 State Convention of the Liberal Party of Australia, NSW Division RESOLVE, by ordinary motion, to:

Review and consider the Rural and Regional Members Survey Report including considering the:

- 1. Creation of a communication channel to offer the party greater utilisation of rural and regional conferences in identifying local issues and providing regular feedback to the local, state, and federal liberal party representatives;
- 2. Creation of candidate and campaign school programmes tailored to rural and regional areas; and
- 3. Organisation of a debate on how the coalition agreements are made and how this impacts rural and regional campaigns.
